I see they have mail on the ground in hopes I can get his name to file a restraining order, but it is all sorts of different peoples mail they appear to be going through.

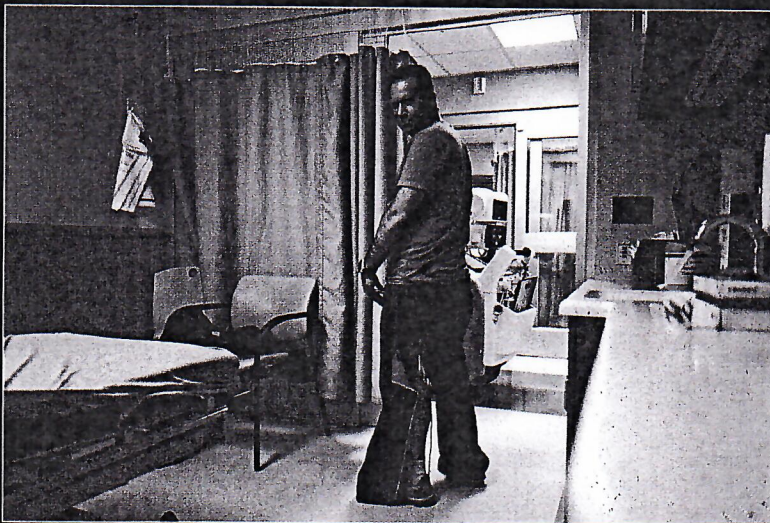
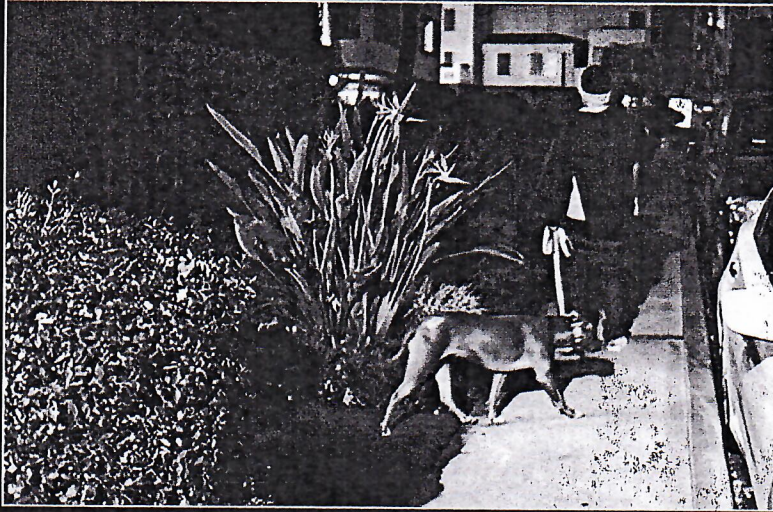
These people are associated with Victoria Walker trying to thug me quiet.
