**Report of Police Retaliation and Misconduct**

Dear Sir/Madam,

I am writing to file a formal complaint regarding what I believe to be a retaliatory measure associated with ongoing misconduct involving the Los Angeles Police Department (LAPD). This includes a recent written demand or enforcement communication that, in light of its timing and surrounding circumstances, appears to have been issued in response to any aspect of the truth about what has been done to my life and the damages.

I am requesting that this matter be taken seriously and reviewed as part of a broader pattern of intimidation intended to silence me and to create the false appearance that I have done something wrong as a form of cover-up. I also ask for intervention to address the use of community-based policing and neighborhood watch programs in a manner that appears designed with nonstop monitoring and provocation, contributing to an atmosphere of pressure and hostility rather than legitimate public safety.

This letter is another example of what I believe to be misconduct and abuse of authority as part of an ongoing pattern involving community-based policing practices directed toward me. I believe these programs have been used in ways that provoke reactions, generate accusations, and shift focus away from the underlying conduct I have attempted to report. The mental illness labeling that has been applied to me since a young age has, in my view, contributed to a narrative that undermines my credibility and discourages serious review of my complaints. I am concerned that such characterizations have been used to dismiss my concerns rather than address them.

I am requesting not only the immediate cessation of retaliatory actions, but also that the conduct described herein be investigated to determine whether constitutional violations, abuse of process, or improper coordination are present. The misuse of authority, represents serious civil rights concerns.

This situation is not recent or isolated, but part of a pattern that has escalated over many years in which I have felt discouraged from speaking about what has happened to me, especially with the ongoing threats and arrests for merely making a statement about these illegal police operations and community policing, and stalking groups helping them. While stating to the people that they merely have been lied to. Since early childhood, there have been repeated efforts within the Perelman family to label me as mentally ill in ways that I believe shaped perceptions about me and justified harmful treatment. I am concerned that these long-standing characterizations have been relied upon and reinforced by individuals with connections to law enforcement and the judicial system, creating a foundation that allows present actions to be excused or overlooked. This history is important context, as it reflects an ongoing narrative that has contributed to the escalation I am now formally bringing forward.

This complaint is being added to my previous documentation and letters submitted to your office as well as other agencies, regarding ongoing police harassment with community members, illegal surveillance, and related proceedings involving the LAPD in nonstop illegal activities directed at me.

I urge the Civil Rights Division to take appropriate action to investigate these serious concerns and ensure that any retaliatory or unconstitutional conduct which has been consistent across the majority of my life is addressed. These actions not only harm me personally, but they also undermine public trust in community policing systems that are intended to serve and protect the public.

### **Context of Retaliation and Protected Protective Speech**

My communications regarding these matters are not merely expressive; they are protective in nature. I have used lawful speech, documentation, and formal complaint mechanisms in an effort to clarify misinformation, request that perceived harassment cease, and prevent escalation. When I speak publicly or file complaints, it is not to create disturbance, but to defend my reputation, safety, and constitutional rights through lawful channels from groups of anonymous strangers who believe I need to be removed from society based on whatever their belief system of the law might be. I have been met with nonstop threats and escalation for speaking out. Whether it is to file police reports or try to tell people what they have been told about me isn't the truth.

My efforts to protect myself through speech are being reframed as misconduct. There have been characterizations suggesting that my attempts to address ongoing hostility or provocation constitute “public nuisance” behavior. I strongly dispute that characterization. When an individual is subjected to sustained misrepresentation or provocation, the act of objecting, clarifying facts, or seeking accountability through lawful speech is not nuisance conduct—it is the exercise of constitutional rights and self-protection through communication.

Instead of addressing the substance of my complaints, actions continually and systematically appear to shift attention to my reactions rather than the conduct that prompted them. Ironically this applies to every aspect of my behavior since early childhood which are perfectly normal behaviors. The collection-style correspondence referenced above should be reviewed within this sequence of events. It was issued following my continued efforts to document and speak about what is misconduct. The timing raises concern that lawful efforts to defend myself through speech are being met with escalating measures that portray me as the source of disturbance rather than as an individual seeking relief.

These circumstances cannot be dismissed as misunderstandings or routine community interactions. When civilian groups operate in ways that result in sustained targeting, provocation, or coordinated hostility toward a single individual with nonstop threats, and when those actions appear aligned with law enforcement narratives about that individual, serious constitutional concerns arise.

If private civilians are acting in concert with or under encouragement from law enforcement in ways that materially contribute to intimidation, mischaracterization, or attempts to manufacture “nuisance”, criminal, mental illness status, that conduct demands scrutiny. Civilians are not empowered to engage in harassment, intimidation, or quasi-enforcement activities that effectively deprive an individual of liberty, safety, or reputation without due process.

I am not the aggressor in this situation. I am the individual attempting to remain free, safe, and law-abiding while responding to conduct that places me at risk of being mischaracterized, isolated, or unjustly confined. My speech has been an act of lawful self-preservation. When I speak, it is because silence would allow a false narrative to solidify unchallenged.

The question is not why I am speaking. The question is why the conduct prompting that speech has not been meaningfully addressed. If my efforts to defend myself through lawful communication are being reframed as instability or nuisance behavior, while coordinated

hostility toward me is tolerated or minimized, that represents a profound inversion of victim and accused.

I am requesting a serious federal review of whether civilian participation in community policing activities has crossed constitutional boundaries and whether retaliatory mechanisms are being used to suppress protected speech. I have the right to remain breathing, free, and outside of a jail cell without being subjected to orchestrated pressure designed to force silence.

This complaint is being added to my **previous documentation and letters** submitted to your office regarding the **ongoing police harassment, illegal surveillance, and unlawful trials** involving the LAPD.

I urge the **Civil Rights Division, FBI, and all other oversight agencies** to take immediate action to investigate these **serious violations** and ensure that those responsible for these **retaliatory tactics** are held accountable. These actions not only harm me personally, but they also undermine the trust and integrity of the community policing systems that are supposed to serve and protect the public.
